General Terms and Conditions of Business for the acquisition and usage of Mondo Community Coins

CBNS CRYPTO BUY AND SELL DMCC operates an eCommerce platform on its website https://mondo.shopping (hereinafter the "Website of Mondo"). In order to intensify the use of the advantages of this eCommerce platform, CBNS CRYPTO BUY AND SEL DMCC invites to acquire Mondo Community Coins. The following terms and conditions govern the purchase of Mondo Community Coins and how they can be used as vouchers on the Mondo website:

### 1. Definitions

"GTC" meaning these mutual general terms and conditions.

The "eCommerce platform" has the assigned term in Section 2.2

"Individual wallet" has the term assigned under Section 6.2 too important.

"Mondo" has this assigned term in section 2.1 too important.

"Token" has this assigned term in section 2.1 too important.

"Waterfall mechanisms" has the assigned term under 6.4 too important.

"Website of the Mondo" has the assigned term in the preamble.

### 2. Offer

- 2.1 CBNS CRYPTO BUY AND SELL DMCC (hereinafter "Mondo") invites interested buyers to purchase Mondo Community Coins (hereinafter individually and in plural "Token") within the scope of an Initial Coin Offering (ICO) under the following conditions. The number of tokens that can be purchased as part of the ICO is up to 180,000,000 (in words: one hundred and eighty million). The purchase price per token is EUR 1.00 (in words: one euro). Mondo reserves the right to also grant tokens via airdrop marketing campaigns.
- 2.2 Each token is a digital voucher token (utility token), which is available exclusively on the Mondo Shopping eCommerce marketplace (https://mondo.shopping), an online marketplace for retailers of various goods and services ("eCommerce platform"), which is operated by Mondo and can be used to redeem the services listed under Section 5.1.

## 3. Conclusion of Contract

3.1 The contract for the purchase of tokens is concluded exclusively via the online purchase route set up for this on the Mondo website. The successful registration of the purchaser on the website for the online purchase route [https://connect.mondo-blockchain.com] is required to execute the contract. Within the online purchase process, the purchaser selects the number of tokens he wants and collects them in his personal virtual shopping cart by clicking the "Add to shopping cart" button. By clicking the "payable order" button at the end of the online purchase process, the purchaser submits a legally binding offer to purchase the tokens in their virtual shopping cart. Before submitting his binding offer by clicking on the "payable order" button, the purchaser can view and change his details at any time or cancel the purchase process.

- 3.2 The contract for the purchase of tokens is concluded exclusively based on the information provided by Mondo and the respective purchaser in the context of the conclusion of the purchase contract via the online purchase route and based on these GTC. Even before submitting his legally binding offer, the purchaser receives these terms and conditions, a non-binding order overview, the legal information for contracts concluded outside of business premises and distance contracts except for contracts for financial services, including the instruction on the legal right of withdrawal, risk information and the Token White Paper of the sent via email by Mondo. In addition, during the payment process, in order to continue, the purchaser must confirm receipt and knowledge of the aforementioned and provided documents by ticking the box.
- 3.3 Following the process described in Sections 3.1 and 3.2, Mondo will send the purchaser an automatic confirmation of receipt to the e-mail address given by him, in which his token order is listed again. The automatic confirmation of receipt only documents that the order has been received by Mondo and does not constitute acceptance of the offer by the purchaser. Mondo is not obliged to accept an offer and reserves the right to not accept an offer, especially if offers for the acquisition are in total volume higher than the maximum number of tokens issued mentioned under 2.1. The purchase contract is only concluded when the purchaser receives Mondo's declaration of acceptance in a separate email, which also contains a copy of the complete contract for the tokens acquired by the purchaser.

# 4. Period during which the token can be purchased. Restriction of the circle of acquirers

- 4.1 Mondo invites to submit offers to purchase tokens in the period from January 1, 2021 to December 31, 2022 (offer time period).
- 4.2 Mondo offers the purchase of tokens exclusively for people residing outside of the USA. Excluded from the acquisition of the token are persons who are citizens of the USA or who are holder of permanent residence and work permit or who have their residence or headquarters there or in its territories or who are established or organized according to their law and whose income is subject to tax law there or is on a sanction list of the EU or the USA. With his offer to acquire and purchase tokens, the purchaser assures Mondo that he does not belong to the above group of people.

## 5. Benefits associated with the token. Use of the tokens on the Mondo website

- 5.1 Acquirers who have acquired tokens in accordance with the procedures described in sections 1 to 4 above can redeem the tokens on the Mondo website in the manner described in section 7. The redemption takes place as a voucher against the possibility of using the following services:
- **5.1.1** Every purchaser can redeem tokens for the following services offered on the Mondo website for token holders:
  - Organizing or participating in Mondo.academy events. The Mondo.academy offers virtual learning and educational events as well as virtual meetings (comparable to zoom calls).
  - b. Offers on the platform level entertainment shopping (Mondo.Games). Various computer games can be played in the Mondo.Games games lounge against redemption of tokens.

- c. Offers from the Mondo.ConcertHall. The Mondo.Concert-Hall offers virtual artistic entertainment by various artists (e.g. live concerts, dance theater; magic shows), as well as the opportunity to organize such virtual events yourself.
- **5.1.2.** Acquirers who are eCommerce shop operators and who conduct online trade with their goods and / or services via their eCommerce shop can redeem, subject to sentence 2, tokens for the following services offered on the Mondo website for token holders (hereinafter "Shop advantages"):
  - a. Granting of a Power-Seller-Status
  - b. advantageous placement of the shop on the Mondo shopping platform
  - c. Special features (prominent mention in thematic areas of the platform).

The redemption of tokens to claim shop benefits according to number. 5.1.2 Clause 1, requires imperatively the admission of the online retailers on the Mondo. Shopping eCommerce platform in advance. The Mondo is not obliged to add an online retailer to the eCommerce platform. The acquisition of tokens does not result in the obligation of Mondo to list a token holder as an online retailer on the Mondo. Shopping eCommerce platform.

- **5.1.3**. The exact time and / or scope of the possible use of the aforementioned services as well as the number of tokens that must be redeemed in order to use the service at Mondo according to the procedure described in Section 7 can be found in the information on the website of Mondo related to the services offered in each case.
- 5.2 The token does not currently provide buyers with any rights beyond the use of the aforementioned services under the conditions mentioned, in particular no membership administrative rights, namely expressly no participation, participation, voting, instruction, information or other administrative rights under company law, neither in relation to the Mondo, nor in relation to another person.
- 5.3 The token does not serve as a means of carrying out payment transactions and is also not accepted by the issuer for carrying out payment transactions.
- 5.4 The token does not grant any financial rights towards Mondo, in particular not for repayment of the purchase and / or payment of a dividend, distribution or other financial contribution. This does not affect the right to return the token against reimbursement of the amount paid in Euros upon a legally exercised revocation in the event that the statutory right of revocation exists.
- **5.5** Mondo reserves the right to offer further benefits in return for the redemption of tokens in the future.
- **5.6** Mondo is entitled to acquire or hold tokens itself.
- 6. Tokenization, wallet, staggered activation (waterfall) and transfer of tokens
- 6.1 The token becomes a digital Smart contract (according to the ERC-20 standard) on the public Ethereum blockchain. As a digital voucher on the public Ethereum blockchain, it embodies the possibility of obtaining the preservation of benefits listed in Section 5.1 for buyers.
- 6.2 The prerequisite for receiving tokens, subject to Airdrop marketing, apart from to the effective conclusion of a contract and the transfer of the purchase price for the purchased tokens to the Mondo bank account specified in the online purchase route, is the notification

of an Ethereum Public Blockchain-compatible, personal electronic wallet ("Individual Wallet") to the Mondo.

- 6.3 For this purpose, the purchaser can indicate his existing Ethereum public blockchain-compatible wallet address as part of the online purchase route. If the purchaser does not have his own Ethereum-compatible personal electronic wallet or does not want to use it, he has the option to receive a wallet from a recommended wallet provider as part of the online purchase process, via a corresponding link to the website of a wallet provider. For the time the purchaser is the owner of the token, Mondo will assume the costs for this wallet, which is made available by the wallet provider link on the online purchase route.
- 6.4 If the aforementioned requirements for the receipt of tokens are met, Mondo will issue a number of tokens corresponding to the amount purchased from its master wallet to the individual wallet of the purchaser. Not all tokens will be immediately available for redemption to receive the Mondo services described under 5.1. Rather, the tokens are activated with a time delay in the purchaser's individual wallet for actual redemption on the Mondo. Shopping eCommerce platform. The reason for this is a delay mechanism installed in the token. This delay mechanism leads to the following delay in the redeemability of received tokens on the Mondo. Shopping eCommerce platform: Within the first twenty (20) months after the day of receipt or an individually agreed date of one or more tokens in his individual wallet (due date), the acquirers will have 0.5% of all tokens received available on the respective key date in their individual wallet for redemption on the eCommerce platform and made redeemable each month. This means that twenty (20) months after a key date, 10% of all tokens acquired after this key date are available for redemption on the eCommerce platform. In the following months twenty-one (21) to twenty-nine (29) after the respective reference date, a further 10% of the tokens acquired on this respective reference date will be activated and redeemable for the purchaser in his individual wallet, so that the purchaser will have 100% of the tokens acquired on this key date available for redemption meaning after twenty-nine (29) months, also called "waterfall mechanism" or "vesting", is completed.
- 6.5 After receiving tokens on their individual wallet, the purchaser has the option of transferring the Mondo tokens to third parties instead of redeeming them on the website, taking into account the provisions under sections 4.2 and 6.4.
- 6.6 For the transfer of tokens on the Ethereum Public Blockchain, individual transaction costs are incurred, which must be paid in the public blockchain-internal crypto currency Ether (ETH). The transaction costs for the initial transfer of purchased tokens from the Mondo's master wallet to the purchaser's individual wallet are borne by Mondo, provided that the purchaser has set up his individual wallet with the wallet provider linked via the online purchase route. Otherwise and for all further transactions within the scope of redeeming tokens or when transferring them to third parties, the purchaser must pay the transaction costs himself. In order to pay such transaction costs on the Public Ethereum Blockchain in Ether (ETH), the person who bears the costs must fill their individual wallet with an appropriate amount of Ether (ETH).

# 7. Redeeming tokens on the eCommerce platform, transferring them back to the Mondo wallet

Acquirers have the option of redeeming their tokens activated in accordance with the waterfall mechanism on the Mondo. Shopping eCommerce platform for the services described in Section 5.1. This is done in an individual, password-protected area (user area) on the Mondo website, which is set up for the purchaser as part of the registration process in

accordance with Section 3.1 when completing the online purchase route. Acquirers can then choose from the advantages shown listed under in Section 5.1. as part of the subsequent binding redemption process, the purchaser redeems the required number of tokens in the user area in order to receive the selected service. The process for redeeming tokens is completed when the purchaser has transferred the amount of tokens corresponding to the amount of tokens upon redeeming from his individual wallet back to a Mondo wallet. The purchaser can only use the desired service after the required number of tokens have been transferred back.

## 8. Applicable law, place of jurisdiction

- **8.1** The law of the Federal Republic of Germany applies to the rights and obligations of Mondo and the purchaser resulting from the acquisition of the tokens.
- 8.2 The non-exclusive place of jurisdiction for all legal disputes arising from the legal relationship between the purchaser and Mondo is the registered office of Mondo. This jurisdiction agreement does not limit the right of an acquirer to initiate proceedings before another competent court. The initiation of proceedings before one or more other places of jurisdiction does not exclude the initiation of proceedings at another place of jurisdiction, if and to the extent that this is legally permissible.
