

# Mondo Community Coin

## **Information obligations for contracts and distance selling contracts concluded outside of business premises apart from contracts for financial services, § § 312d Abs. 1 BGB, Art. 246a §§ 1, 4 EGBG**

CBNS CRYPTO BUY AND SELL DMCC („CBNS“), as a declaring entrepreneur, is obliged to act as a declaring entrepreneur in accordance with Section 312d (1) sentence 1 of the German Civil Code (BGB), in the event of a contract concluded outside of business premises or a distance contract except for contracts for financial services in accordance with Art. 246a of the Introductory Act to the Civil Code (EGBGB). The information must be made available to the consumer in a clear and understandable manner before submitting his contractual declaration. In context thereto, buyers who want to conclude a contract for the purchase of Mondo Community Coins with the CBNS on the eCommerce platform (<http://mondo.shopping>) as consumers within the meaning of § 13 BGB will be able to use the following information (in The following: "Consumer information"):

### **1. The essential characteristics of the goods or services to the extent appropriate for the means of communication and for the goods and services**

The Mondo Community Coin is a digital voucher token that functions on the Public Ethereum Blockchain and is redeemable on the CBNS eCommerce platform (<http://mondo.shopping>) by every Mondo Community Coin holder for the receipt of available Services:

- a. Organizing or participating in Mondo.academy events. The Mondo.academy offers virtual learning and educational events as well as virtual meetings (comparable to zoom calls).
- b. Offers on the platform level entertainment shopping (Mondo.Games). Various computer games can be played in the Mondo.Games games lounge against redemption of tokens.
- c. Offers from the Mondo.Concert-Hall. The Mondo.Concert-Hall offers virtual artistic entertainment by various artists (e.g. live concerts, dance theater; magic shows), as well as the opportunity to organize such virtual events yourself.

The above services a. to c. can be used by all purchasers of the Mondo Community Coin, i.e. those who are consumers within the meaning of § 13 BGB, and those who are not consumers within the meaning of § 13 BGB, on the platform (<http://mondo.shopping>) be taken.

In addition to the above services, purchasers who are not consumers within the meaning of Section 13 BGB and who have been registered as an online shop owner on the eCommerce platform (<http://mondo.shopping>) can receive the following additional services against redemption by Mondo Use Community Coins:

- a. Receipt of a power seller status
- b. advantageous placement of the shop on the Mondo shopping platform

c. Special features (prominent mention in thematic areas of the platform).

Holders of Mondo Community Coins who purchase the tokens as consumers within the meaning of § 13 BGB are not entitled to the above-mentioned additional services a. to c.

The CBNS reserves the right to offer further advantages as a service for the redemption of Mondo Community Coins on the eCommerce platform.

For a comprehensive description of the properties of the Mondo Community Coin, please refer to our General Terms and Conditions (GTC).

**2. Identity of the entrepreneur, for example his trade name and the address of the place where he is established, his telephone number and e-mail address and, if applicable, the address and identity of the entrepreneur on whose behalf he is acting**

**3. In addition to the information in number 2, the business address of the entrepreneur and, if applicable, the address of the entrepreneur on whose behalf he is acting, to which the consumer can address any complaint if this address differs from the address in number 2**

In the event of complaints, the consumer can contact the CBNS business address mentioned in No. 2.

**4. The total price of the goods or services including all taxes and duties and, where applicable, any additional freight, delivery or shipping costs and all other costs, or, in cases where these costs cannot reasonably be calculated in advance, the fact that such additional costs may apply. The costs of using the means of distance communication required to conclude the contract, provided that the consumer is charged costs that go beyond the costs of using the means of distance communication.**

The total price is EUR 1.00 gross per Mondo Community Coin. For the transfer of Mondo Community Coins on the Ethereum Public Blockchain, individual transaction costs incurred, which are to be paid in the public blockchain-internal crypto currency Ether (ETH). The transaction costs for the initial transfer within the scope of the acquisition of Mondo Community Coins from the master wallet of the CBNS to the individual wallet of the purchaser are borne by the CBNS, provided that the purchaser uses the online system set up by CBNS to transfer his individual wallet -professional route linked wallet provider. Otherwise - as for all other transactions in connection with the redemption of Mondo Community Coins or when transferring them to third parties - the purchaser or, if applicable, the third party must pay the transaction costs themselves. The CBNS does not charge the consumer for the use of the means of remote communication used to conclude the contract.

**5. The terms of payment, delivery and service, the deadline by which the entrepreneur must deliver the goods or provide the services and, if applicable, the entrepreneur's procedure for handling complaints**

As a payment method for the purchase of Mondo Community Coins, the CBNS offers Paypal, Stripe, Klarna or bank transfer to the business account specified by it. CBNS reserves the right to integrate other payment service providers who make the purchase process easier for the customer and CBNS. The delivery of the Mondo Community Coins to the buyer takes place exclusively on the public Ethereum blockchain by transferring them to the individual

wallet set up there for the buyer ("electronic wallet"). The delivery takes place only under the following conditions: Existence of an effective sales contract; Notification of an existing or installation of an individual wallet of the purchaser that is ready to receive on the Public Ethereum Blockchain; (subject to airdrop marketing) Receipt of the purchase price by the CBNS. The details of the conditions for the delivery of Mondo Community Tokens can be found in Section 6 of the General Terms and Conditions. The transfer of acquired Mondo Community Coins to the individual wallet of the purchaser takes place shortly after the statutory withdrawal period has expired. Since the Mondo Community Coins are provided with a so-called delay mechanism (waterfall mechanism), the purchaser cannot redeem the Mondo Community Coins received in his wallet right away for services of the CBNS on the eCommerce platform; A waiting period for the time delay associated with the mechanism before the coins can be used. For the details of the waterfall mechanism, reference is made to Section 6.5 of the General Terms and Conditions for the contract for the purchase and use of Mondo Community Coins. There is no special procedure for dealing with complaints from purchasers of the Mondo Community Coin on the CBNS. Every incoming complaint is dealt with immediately.

**6. The existence of a statutory right to liability for defects for the goods. If applicable, the existence and conditions of customer service, customer services and guarantees. Relevant codes of conduct, if any, and how to obtain them**

The statutory provisions apply to the warranty in the event of defects. There is no special customer service, customer service or guarantees for purchasers of Mondo Community Coins. There are no special codes of conduct, particularly relating to unfair business practices to which the CBNS has subjected.

**7. If applicable, the duration of the contract or the conditions for terminating open-ended contracts or automatically renewing contracts. If applicable, the minimum duration of the obligations that the consumer enters into with the contract. If necessary, the fact that the entrepreneur can demand the provision of a deposit or other financial security from the consumer, as well as the conditions thereof**

The purchase contract for Mondo Community Coins has no minimum term. The contracting parties do not have a contractual right to (ordinary) termination of the contract for the acquisition of Mondo Community Coins. For the duration of the ownership of Mondo Community Coins, the purchaser is obliged to adhere to the agreed contractual rules to which the Mondo Community Coin was granted and for which it can be used. The CBNS cannot require the purchaser of Mondo Community Coins to provide a deposit or other financial securities.

**8. If applicable, the functioning of digital content, including applicable technical protective measures for such content**

**8.1 How it functions**

Technically, the Mondo Community Coin is a usage token or utility token issued on the public Ethereum blockchain, which can be understood as a digital voucher. The rights that make up the voucher to make use of the services described above under item 1 are mapped on the Public Ethereum Blockchain by a smart contract based on the ERC-20 standard. The Public Ethereum Blockchain is one of the world's largest, public and unrestrictedly accessible blockchains. This is a worldwide, decentralized network currently stored in over 8,000 servers, which maintains a uniform and unchangeable data set within a chain of blocks (i.e. blockchain). A smart contract is a type of computer program or software that enables, among other things, the creation and transfer of tokens such as the Mondo Community Coin on the blockchain. Mondo Community Coins sold to an acquirer are transferred by the CBNS from their digital purse or electronic wallet on the Public Ethereum Blockchain to the personal wallet set up for

the acquirer on the Public Ethereum Blockchain or to their individual Public Ethereum assigned to the wallet Address (public key). Mondo Community Coins transferred to the wallet of the purchaser are not immediately available for use as a digital voucher on the eCommerce platform of the CBNS, but first go through the delay mechanism (waterfall mechanism) regulated under Section 6.5 of the GTC before they can be used. To use services, the purchaser redeems the number of Mondo Community Coins required for the respective service on the CBNS. For this purpose, again based on the technology of the smart contract, the required number of Mondo Community Coins must be transferred from the individual wallet of the purchaser to a wallet on the CBNS.

## 8.2 Technical protective measures

The use of Public Ethereum Blockchain technology for the use of Mondo Community Coins as such serves the purpose of technical protection. The aim of the Public Ethereum Blockchain is to create the highest possible transaction security through the use of the techniques of chaining blocks (so-called blockchain) and the distributed ledger as well as verification by means of the consensus mechanism. On the (Public Ethereum) blockchain, all information that has ever been saved or changes made are cryptographically linked to form "blocks" of individual data records. The sequence of events is documented change-proof on the blockchain by providing each block with a time stamp and a cryptographic checksum of the previous block. The content of the respective blocks are transactions. Before a new block is added to the blockchain, the transactions to be included in this block are first verified by a large number of participants in the so-called consensus procedure. The blockchain is stored locally and decentral by all participants (so-called nodes and miners) and continuously synchronized between them (so-called distributed ledger technology). If, while the blockchain is being updated, there is a - technically possible - simultaneous generation of several new blocks, a branch is created in the chain. In this case, when creating the next block, the longest of these chains is used as evidence of the sequence of events. This is based on the idea that the longest chain was generated by the greatest computing power in the network and is therefore the most trustworthy. The blocks of the shorter branch are discarded and the information contained in these blocks is re-examined before it is then appended to the longer chain. A block is therefore a checked bundle of information that is linked to the preceding and following blocks. Since a change in the content of a block always results in its cryptographic checksum also changing, manipulation is always recognizable due to the deviation of this checksum from the checksum documented in the following block. If a potential attacker wants to manipulate the content of a block, he would also have to manipulate all subsequent blocks, which is accordingly very difficult or virtually impossible.

In addition, a transfer of Mondo Community Coins can only be initiated by a corresponding notification from the coin holder (or, if applicable, an authorized wallet provider) to the blockchain network. The authorization for the transfer is verified via the use of the private cryptographic key (private key) known only to the coin holder (or, if applicable, the authorized wallet provider) (signature of the transaction).

As a further technical protective measure against unauthorized or improper use of purchased Mondo Community Coins by third parties on the eCommerce platform of the CBNS, a prior personal registration in the user area of the eCommerce platform of the CBNS is always required. In order to enter the user area, in which the purchased Mondo Community Coins can be redeemed against the CBNS, the selected user is required to enter name or the email address and password of the user, i.e. the coin holder, beforehand.

**9. If necessary, as far as material, restrictions on the interoperability and compatibility of digital content with hardware and software, insofar as these restrictions are known or must be known to the entrepreneur**

The Mondo Community Coins are created on the Public Ethereum Blockchain by means of a so-called Smart Contract according to the ERC-20 standard and can only be received and transmitted there. Buyers who want to receive and / or transfer Mondo Community Coins therefore also need an Ethereum blockchain-compatible wallet that can receive and transfer tokens created according to the ERC-20 standard. Outside the public Ethereum blockchain, e.g. on other public or private blockchains, the token can neither be received nor transferred, or when transferred to wallets that are not Ethereum blockchain-compatible there is a risk that the Mondo Community Coins will be lost. In addition, transactions on the public Ethereum blockchain can only be carried out if the transaction is supported by the use of gas. Only ether (ETH), the cryptocurrency of the public Ethereum blockchain, is accepted as gas, but not other cryptocurrencies that are incompatible in this respect.

**10. If necessary, the consumer can use an out-of-court complaint and legal remedy procedure to which the entrepreneur is subject, and its access requirements**

The CBNS has not submitted to any out-of-court complaint and appeal procedures. The ordinary court process applies to any disputes.

**11. Instructions on the right of cancellation, the execution and legal consequences of a cancellation**

Purchasers who are consumers within the meaning of Section 13 of the German Civil Code (BGB) and who conclude the contract for the acquisition of Mondo Community Coins outside of business premises or purchase via distance contract have the statutory right of withdrawal for contracts concluded outside of business premises or distance contracts in accordance with Section 312g Paragraph 1, 355 BGB.

**Right of withdrawal**

**Right of withdrawal**

You have the right to withdraw from this contract within fourteen days without giving any reason. The cancellation period is fourteen days from the day of payment on which you or a third party named by you has paid for the goods.

In order to exercise your right of withdrawal, you must inform us (Unit No: 1984 DMCC Business Centre Level No 1 Jewellery & Gemplex 3 Dubai United Arab Emirates, E-Mail-Adresse: welcome@cbns.pro) by means of a clear declaration (e.g. a letter sent by post or email) informing about your decision to withdraw from this contract. You can use the attached model withdrawal form for this purpose, but this is not mandatory.

To meet the withdrawal deadline, it is sufficient for you to send your notification of exercising your right of withdrawal before the withdrawal period has expired.

#### Consequences of withdrawal

If you withdraw from this contract, we will have given you all payments that we have received from you, including delivery costs (with the exception of the additional costs that result from choosing a different type of delivery than the cheapest standard delivery offered by us), to be repaid immediately and at the latest within fourteen days from the day on which we received notification of your cancellation of this contract. For this repayment, we will use the same means of payment that you used for the original transaction, unless something else was expressly agreed with you; In no case will you be charged any fees for this repayment. We can refuse repayment until we have received the goods back or until you have provided evidence that you have sent the goods back, whichever is earlier. You must return or hand over the goods to us immediately and in any case no later than fourteen days from the date on which you informed us of the cancellation of this contract. The deadline is met if you send the goods before the period of fourteen days has expired. You bear the direct costs of returning the goods.

NOTE: The term "goods" or "goods" in the above (sample) cancellation policy means in the present context the Mondo Community Coins you have acquired.

Information from CBNS CRYPTO BUY AND SELL DMCC („CBNS“) as the declaring entrepreneur in accordance with Section 312i Paragraph 1 Sentence 1 No. 2 of the Civil Code (BGB) in

conjunction with Art. 246c of the Introductory Act to the Civil Code (EGBGB) due to the use Telemedia for the purpose of concluding a contract for the delivery of goods or for the provision of services:

### **1. About individual technical steps that lead to the conclusion of a contract**

The Mondo Community Coins presented on our website (especially in our shopping cart) or in forms do not represent a binding offer from us to you. To do this, after successful personal registration, go through the individual steps of the online purchase route we have set up and put the desired number of Mondo Community Coins in your personal shopping cart by clicking the corresponding button. By clicking the "order with obligation to pay" button, you are submitting a binding offer to us to conclude the purchase contract. Following this, we will send you a confirmation of receipt by e-mail, which informs you about the receipt of your offer and its content, but does not represent an acceptance of your offer by us. The purchase contract is only concluded when you receive the declaration of acceptance from the CBNS in a separate email, which also contains a copy of the complete contract for the tokens you have purchased.

### **2. Whether the contract text is saved by the entrepreneur after the contract is concluded and whether it is accessible to the customer**

The text of the contract is not saved by us after the conclusion of the contract and is therefore no longer accessible or retrievable from us after the contract has been concluded. The text of the contract is made available to you by sending it as a PDF in the e-mail "Order overview, terms and conditions, consumer information" as part of the online purchase route and by (compulsory) downloading of the PDF file "order overview, terms and conditions, consumer information" as part of the online purchase route made. In addition, you can call up our terms and conditions - both the currently valid ones and those valid at the time of the conclusion of the contract - at any time on our customer portal at <https://connect.mondo-coin.com>.
